



Jacobs Camp 2020 Registration Terms & Policies

Terms and Conditions Agreement:

The below Terms and Conditions are acknowledged and agreed to by and between the Union for Reform Judaism's (URJ) Jacobs Camp and the undersigned parent or guardian (referred to herein as "parent", "guardian", "I" or "me") on behalf of Parent or Guardian's child (hereafter "Camper") and represent the expectations and agreements in order to be eligible for acceptance to Camp:

- Requirements for Acceptance to Session at Camp
- Deposit and Family's Payment Agreement
- Refund of Payment Policies
- Program Coverage
- Camper's Participation and Camp Program Expectation
- Recording Release
- Indemnification

In the mutual interest of the camp, the camper, and for the well-being of all campers at the camp, I understand that campers must respect and observe the rules, regulations and policies of the camp, which have been developed for the benefit of all campers to strengthen the camp program and enhance the experience for all campers. In particular, as parent/guardian of camp, I agree to the implementation and enforcement of the following rules, regulations and policies at camp for the 2020 summer camping season, and which are part of this agreement, and have reviewed these rules, regulations and policies with camper:

Requirement for Acceptance to Session at Camp:

- I agree that camper's acceptance into session at camp is not confirmed until explicit written verification is received from the camp, which notice will usually come from camp via email to the email address established by me in my application.
- I understand that this application is accepted subject to a physical examination of camper by a physician and the completion (and the submission) of all necessary forms (medical, camper's information, etc.) in accordance with camp policy.
- I understand that the URJ, its camping system, and the camp consider camp safety and public health matters of maintaining a safe environment and in decreasing the risk of transmission of contagious illness. Accordingly, camp and the URJ camping system requires that any member of the camp community in residence receive up-to-date, age appropriate immunizations. The complete list of required immunizations and exemptions can be found on the camp's health forms.
- I agree to provide proof of medical insurance covering camper prior to the beginning of the camp season. Medical insurance for camper can be purchased for the period at



camp through the camp insurance company. (Please contact Jacobs' camp office for more information.)

Deposits and Family's Payment Agreement:

- I agree to submit \$250 per camper/per session deposit (subject to the stated refund policy) in order to have camper's application processed.
- Payment of at least \$1000/camp/session camper's balance is due by 02/01/2020 with balance due by 05/01/2020. Statements will be emailed.
- I agree after 04/01/2020, a cancellation fee of \$1000 will be applied.
- I agree any cancellations after 05/01/2020 will forfeit all fees.

Refunds of Payment Policies

- Full refunds will be given (without penalty) for campers on a "Waiting List" (those not able to be placed in their desired session at camp) if at any time they choose to be removed from the list or are ultimately unable to be placed.
- Should camper be withdrawn from camp for treatment of an illness contracted at camp or for any accident while camper is living at camp, a refund on a pro-rated basis will be made for the period of the camper's departure from camp.
- Refund will not be made if camper has attended any portion of the session at camp. This covers all circumstances (barring the exception above), including, but not limited to:
 - Camper's homesickness
 - Camper's refusal or inability to participate in normal activities at camp
 - Camper's violation of any rules, regulations or policies, at camp for which camper has been provided notice, as described below in "Camper's Participation and Camp Program Expectations" section.

Program Coverage:

- I understand that the camp insurance will, for camp's non-negligent accident occurrence, cover all the costs above and beyond those reimbursements made by camper's family's insurance plan up to a maximum of \$5000. All camper's non-accident health-care requirements which are not camp-related will be at camper's family's expense. A copy of the insurance settlement must be submitted with all claims for reimbursement. I hereby waive any and all claims for medical expenses for camp's non-negligent accident over and above that set forth in this paragraph.

Camper's Participation and Camp Program Expectations:

- I agree to have camper in attendance at camp on-time and for the full extent of camper's scheduled session. Accommodations for late arrival, early departure and/or excused absence must be made in writing in advance of the scheduled session, when



possible, and will only be granted then, or otherwise when possible, with written permission of the camp.

- I understand that I, as parent or guardian, am responsible for all transportation to and from camp. Please refer to the Jacobs Camp's Family Handbook for further travel instructions.
- I hereby give permission and acknowledge the expectation for camper to engage in all activities (except as noted on the Health Form and acknowledged by camp).
- I agree that all policies regarding the use of technology, cellular/mobile telephones and other related items be enforced, for more details, please refer to the Jacobs Camp's Family Handbook.
- I agree that the Jacobs Camp's Director reserves the right to dismiss camper without refund should camper be found by camp to:
 - disregard camp rules or endanger camper's, other campers' or other persons' safety or well-being at camp including, for example, counselors or other staff.
 - harm himself/herself or other members of the camp community;
 - destroy camp property or the property of another member of the camp community such as counselors or other staff;
 - require consistent one-on-one supervision or supervision beyond the level that can reasonably be provided by the camp or its staff;
 - fail to meet the character and integrity requirements of camp;
 - violate any rule, regulation or policy that camp may have in effect during the session at camp.
- I will abide by and support all camp rules, regulations and policies included in the "Jacobs Camp's Family Handbook".

Parent/Guardian Authorizations:

- Camper's parent/guardian gives permission to camp to provide routine health care, and seek emergency medical treatment including but not limited to ordering x-ray and routine tests. Camper's parent or guardian gives permission for camp to release any of camper's and camper's parent or guardian's records necessary for insurance purposes.
- In case of camper's medical emergency, the parent/guardian hereby give permission to the physician selected by the camp to hospitalize, secure proper treatment for, and to order injection, anesthesia or surgery for camper, as named above. Every effort will be made by the camp to immediately contact camper's parent or guardian in the event of any such emergency. Information may be printed/photocopied for access in an emergency involving camper.
- I authorize the camp medical staff to administer over-the-counter medications- medicines prescribed for camper, including medications that camper brings to camp.



Those listed as medications camper is currently taking, and medications needed in the care and treatment of camper.

- I authorize the use of camper and parent/guardian name and program registration information for the purposes of sharing/verifying affiliation with reported URJ Congregation as well as in camp rosters.
- I authorize future communications via mail, email, text, and phone for the purposes of transactional communications as well as marketing communications for this and other URJ programs. Please know that we do not sell or market email addresses. If you do not wish to receive further communications from the URJ and URJ affiliates you will be able to opt out at that time.
- I authorize the use of participant and parent/guardian's name, social media user information, and contact information for purposes of marketing current and new programs now known or hereafter devised, worldwide in perpetuity until such time that I choose to unsubscribe.
- I hereby give my permission for camper to leave campgrounds to participate in camp programs.

Recording Release:

Except as set forth in the Parent/Guardian Authorization above, parent/guardian also hereby consents to the unlimited recording use and reuse by camp, the URJ and URJ Partners and Affiliates of participant's voice, actions, likeness, first name, appearance and biographical material (i.e. collectively "likeness") in an appropriate manner as determined by camp and the URJ in its reasonable discretion in any and all media now known or hereafter devised including but not limited to live video, live audio, marketing materials and social media posts. The parent/guardian may use all or any part of participant likeness and may alter or modify or regardless of whether the participant is recognizable. The parent/guardian further agrees that camp exclusively owns the registration materials that parent/guardian has provided in connection with the program registration and any photos and video that camp will make of the participant in connection with the camp program (the "materials") and all rights therein and thereto including, without limitation, the right to use the materials and the participants likeness in any and all media now known or hereafter devised worldwide, in perpetuity. The parent/guardian further agrees that camp may use the participant's likeness and materials in connection with promotion, publicity, marketing or advertisement for camp, the URJ, and URJ partners and affiliates including live video and audio broadcasts. The parent/guardian agrees

not to make any claim against camp as a result of the recording or use of the participant's likeness and/or the materials (including, without limitations, any claim that such use invades any right of privacy and/or publicity.)

- I understand that Henry S. Jacobs Camp accepts no responsibility for loss or damage to camper's property (including clothing, equipment, personal effects or money) incurred during the session at camp or while in transit. Camp highly recommends that audio equipment, computer games, money or items with significant material value or sentimental value not be brought to camp. Although every effort is made to return lost or misplaced items, camp cannot be held responsible for camper's misplaced, lost or stolen property.
- In the mutual interests of the camp, camper and other campers, the undersigned parents and guardian's camper herewith enrolled with respect and observe the rules, regulations and policies of camp as laid out in this agreement, and which rules, regulations and camper is sent home, camp's fee and tuition is forfeited.
- I understand the camp reserves the right to amend/update rules and policies as necessary as addendums to be included in the Jacobs Camp Family Handbook.

Indemnification: Except with the respect to the sole negligence of the URJ and its employees, the undersigned camp and his/her parent/guardian (whoever is responsible for camper) hereby release, discharge and hold harmless camp, the URJ and their employees from any and all claims, lawsuits, or other legal causes of action, resulting from and/or relating to the camper's participation in a URJ program, camp, camp events and programs, and the camper's travel to and from camp, such events as programs, and related activities.
